The balance of funds in the account belonging to the fire prevention bureau will be transferred after the account is reconciled on audit. Commissioner Caggiano ordered deposit slips and a stamp.

Commissioners went over the final budget amounts for 2014 and 2015, and reviewed all account reconciliations. Motion to accept financial report was made by Commissioner Purnell; seconded by Commissioner Lewis and carried.

## **Chief's Report**

There were 24 activities for the month of December bringing year to date to 226; 164 were fire calls. The ISO rating came back and it has improved. The Fire Department Bylaws are still with Attorney Bucco for review. The ladder truck company will take the measurements for drop chains, and install them. Applications were received for two new members and they have been added to the fire department roster: Christopher Longobardi, and Malik Humaira. Four firefighters will be starting Fire Fighter One and two other members have signed up for additional classes. Chief Longobardi presented the breakdown of funds disbursed. Last year's protocol was adhered to. Chief Longobardi discussed the issues that he was having with the website. He will try to get the passwords for the website and the host site. The domain host is owned by the fire department. Website issues will be discussed further at the next meeting. Motion to accept Chief's report was made by Commissioner Caggiano; seconded by Commissioner Purnell and carried.

## Fire Official's Report

Fire Official gave his report all is going well with inspections. A total of thirteen inspections for the month and one site plan review. Ken Sudol is training with the Fire Official and will be going out on January 19. A mailbox was installed outside the door in the lobby of the building for the use of the Fire Prevention Bureau. All the red lights are installed — a total of 16 this year. Life figures need to be completed on line after all information is received from Commissioner Caggiano. Motion to accept Fire Official's report was made by Commissioner Purnell; seconded by Commissioner Lewis and carried.

# Correspondence

Letter was received from outgoing clerk Diane Woltman detailing what has been completed through the end of her term in December. Letter was received from the Montville Township Board of Education asking for sporadic use of the commissioners' conference room through the end of June. Motion made to allow the use of the room by Commissioner Lewis; seconded by Commissioner Purnell

and carried. Clerk will also request access through the front door of the building as previously agreed upon.

### **Old Business**

Commissioner Caggiano will check with the State on the payoff amount of the Pension still owed for the Clerk Diane Woltman and Fire Official Joseph Serrecchia, as the amount was not yet available at the time of the meeting. The total 2015 assessment was paid in full

#### **New Business**

Motion was made by Commissioner Lewis, seconded by Commissioner Caggiano to adopt the recommendations of the audit findings as they pertained to reviewing the vouchers (01-2015.) and carried.

Motion was made by Commissioner Purnell, seconded by Commissioner Lewis to approve and adopt the 2015 Budget; motion carried with a vote of 4 aye, 1 absent (02-2015.)

Commissioner Purnell made a motion to appoint Robert Cook as interim commissioner. Motion was seconded by Carl Lewis and carried.

Commissioner Lewis said the floors in Company 2 need to be stripped and waxed. Commissioner Cook will be asked to contact Silver Star to do the floors. He will also ask him to take over the handling the supply orders for the three firehouses, as well as the repairs to the chair lift at Company One.

Motion to adjourn meeting was made by Commissioner Lewis seconded by Commissioner Purnell and carried. Meeting was adjourned by Chairman Berry at 9:07 P.M.

**WHEREAS,** the Annual Budget for the Township of Montville Fire District No. 1 for the fiscal year beginning January 1, 2015 and ending December 31, 2015 has been presented for adoption before the Board of Fire Commissioners of the Township of Montville Fire District No. 1 at its open public meeting of January 8,2015; and

WHEREAS, the budget as introduced is in compliance with the Property Tax levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.), and

WHEREAS, the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

**WHEREAS**, the Annual Budget as presented for adoption reflects Total Revenues of \$570,770.00 which includes amount to be raised by taxation of \$523,800.00 and Total Appropriations of \$570,770.00; and

**WHEREAS**, an election shall be held annually on the third Saturday of February in each established fire district to determine the amount of money to be raised by taxation for the ensuing year.

**NOW, THEREFORE BE IT RESOLVED,** by the Board of Fire Commissioners of the Township of Montville Fire District No. 1, at an open public meeting held on January 8, 2015, that the Annual Budget of the Township of Montville Fire district No 1 for the fiscal year beginning January 1, 2015 and ending December 31, 2015 is hereby adopted and shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$570,000.00, which includes amount to be raised by taxation of \$523,000.00, and Total Appropriations of \$570,000.00; and

**BE IT FURTHER RESOLVED,** that the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

**BE IT FURTHER RESOLVED,** that an annual election shall be held on the third Saturday of February to determine the amount of money to be raised by taxation for the ensuing year. The results of which shall be subsequently certified to the Division and the Municipal Assessor.
