party will be on December 18th. The Department will attend the Christmas tree lighting at town hall and an event at Condurso's. Department elections took place. Jim Longobardi is Chief, Ron Baldwin Deputy Chief, Battalion Chiefs are Carol DaCosta and Allen Cook. Commissioner Cook is checking on the breakaway hoses. New commercial grade hoses are required. Air ejector is not working on 351. Discussion of use of Chiefs car and the purchasing of another vehicle. Clerk to see what District 2 and 3 do regarding the Chiefs car. Motion to accept Chief's report was made by Commissioner Crownover; seconded by Commissioner Cook and carried.

Fire Official's Report

Fire Official Phostole reported that there was a total of 8 home inspections for the month of November. Fire Official reported that they had inspected nine township buildings, six LHUs, and fixed the Knox Box at the barn theater. Added one LHU with the State - surgical center. Fire Official spoke to zoning on the issue with the food trucks. They require permits each time they operate, and they need to be inspected. The Fire Official will take action with the town if the town does not inform them that the trucks are operating. Motion to accept Fire Official's report was made by Commissioner Cook; seconded by Commissioner Crownover and carried.
