# **Chief's Report**

The Chief reported that there were 16 fire calls for the month of May, bringing the year-to-date fire calls to 94, and the total year-to-date activities to 130. The Chief's Alliance is doing a seminar on retention. Tools should be mounted on 350 within the next 2 to 3 weeks. Codes have been set up for inspectors at Knox boxes. Department will be doing fire watch at the fireworks on June 30<sup>th</sup>. The Chief will make an appointment to have the bays in all three

stations power washed. The Chief would like to purchase leaf blowers to clean the bays. The Chief presented a quote to replace the Fire Prevention Bureau car. The department is looking into a possible social activity for the men in September. Motion to accept Chief's report was made by Commissioner Bitterle; seconded by Commissioner Cook and carried.

## Fire Official's Report

Fire Official will be taking the Fire Prevention car (Crown Vic) to get pricing on repairs and will bring the information back to the next meeting. Inspections are ongoing at 2 Changebridge Road, along the Main Street corridor and at the 150 River Road office complex. Fire Official is working on weekend permits for the 4<sup>th</sup> of July, the Relay 4 Life and 1 Montville events. The Fire Official will be attending the flag retirement. Rims system remains down – new system not in operation yet. Motion to accept Fire Official's report was made by Commissioner Bitterle; seconded by Commissioner Cook and carried.
