The Christmas party will be held on December 17th and the Santa run will be on December 16th. 354 pump test was done: awaiting the report for the results. Truck 351 is aging out. Apparatus testing is complete. Flow testing on the packs will be starting soon. Some of the packs are aging out. Nifers system is changing to Enifers. Training is ongoing. Motion to accept Chief's report was made by Commissioner Crownover; seconded by Commissioner Bitterle and carried.

Fire Official's Report

The Acting Fire Official reported that the inspections on the LHUs need to be completed. He discussed needing to find help with the commissioners. Requested that the fees be raised. Mike Cowley has resigned. The repairs on the Crown Vic have been completed. There were 8 changes of occupancy for October. Motion to accept Fire Official's report was made by Commissioner Bitterle; seconded by Commissioner Cook and carried.
