Commissioner Caggiano reported that the Workman's Comp refund check had been received as well as the second tax levy check. The commissioners reviewed the budget line items and found all in line at this time. Included in this month's disbursements is a payment in the amount

of \$16,000 for hoses. Commissioners spoke about next year's budget. Motion to accept financial report was made by Commissioner Cook; seconded by Commissioner Bitterle and carried.

Chief's Report

Chief reported that there were 15 fire calls for the month of September, bringing the year-to-date fire calls to 166, and the total year to date activities to 244. The Chief reported that there was a unit in Longview that had several carbon monoxide alarms and that they are unable to determine the source. They are currently undergoing environmental work. If it happens again, they will call Hazmat. There is currently one person attending FF 1. They are still working on loading equipment onto the new ladder truck. The Chief spoke to the county regarding Montville dispatch. There have been instances where there have been delays in dispatching Montville. The county is going to see about breaking out the three departments. Motion to accept Chief's report was made by Commissioner Crownover; seconded by Commissioner Bitterle and carried.

Fire Official's Report

Fire Official Phostole reported that there was a total of 12 home inspections for the month of September. Fire Official reported that the Montville Day inspections were done. The trucks needed to be realigned for the event. All paperwork has been completed. Fire prevention month was conducted at William Mason school for kindergarten and first grade students. The Fire Marshall was there. There is an outpatient drug counseling center going in and this may have to be classified as an LHU. The township buildings need to be inspected. Police department was completed. Reviewed the V&V property. Motion to accept Fire Official's report was made by Commissioner Caggiano; seconded by Commissioner Cook and carried.
