### **Minutes**

The minutes of the meeting of November 11 were read and accepted as read. Motion to accept made by Commissioner Purnell, seconded by Commissioner Cook and carried.

## **Public Comment**

Loiza Grueuska appeared before the commissioners as the property owner of 60 Boonton Avenue. She discussed several issues with the property which abuts station two. She spoke of the monuments and her wish to sell the property. Questions arose regarding the property lines and she will return in January with a survey. Matter has been tabled till the January meeting.

## Chief's Report

The Chief reported 16 activities for the month of November bringing the total for the year to 323; 240 of which were fire calls. Chief reported that he received an application for a new member for company one – Matthew L Berowski and that JD Coleman has returned to town and will be active again. The radios have been installed in the new rescue truck.

All the main equipment has now been transferred to the new truck. Ladder truck is back in service. Discussion regarding the clothing allowance. Motion to accept the Chief's report was made by Commissioner Schmidt, seconded by Commissioner Purnell, and carried.

Fire Official's Report

Fire Official Serrecchia reported that there were a total of 8 home inspections for the month of November. The Township Committee has passed the ordinance on the permit fees. All of the Life Hazards have been inspected for 2018. Fire Official Serrecchia appeared in court and neither one of the owners of the two companies appeared as scheduled. The court date was rescheduled to last week at which time one of the matters was settled after speaking to the party involved. The other matter is being addressed by the court. Motion to accept the Fire Officials report was made by Commissioner Cook; seconded by Commissioner Schmidt, and carried.

Commissioner Purnell will be attending the next Park Commission meeting to speak to them again regarding the issues the men are having when asked to respond to mutual aid at the county parks in the township. Sirens have been repaired at Company Two. The fuel door is being replaced at Company One.

### **New Business**

On a motion made by Commissioner Purnell and seconded by Commissioner Cook the commissioners accepted the application of Matthew L Borowski as a new member assigned to Company One. All in favor. The corrective action plan noted in the 2017 audit was read and discussed. On a motion made by Commissioner Cook and seconded by Commissioner Schmidt the commissioners accepted the plan. The commissioners reviewed the changes made by the State of New Jersey to the introduced 2018 budget. On a motion made by Commissioner Purnell and seconded by Commissioner Schmidt the commissioners unanimously adopted the revised 2018 budget.

Adjournment

Motion to adjourn the meeting was made by Commissioner Purnell and seconded by Commissioner Schmidt, and carried. Meeting was adjourned by Chairman Lewis at 9:18 PM.
