Chief's Report

There were 27 activities for the month of December bringing the final total for 2017 to 278; 202 of which were fire calls. Chief Baldwin reported that the main focus this year would be on recruiting new members and member retention and training. There is also a need for equipment updates. There are several training courses the department would like to take part in. They will try to open some of them to mutual aid towns to try to keep costs down. The chief was asked to furnish a schedule of amounts paid to the officers for clothing allowance, and final percentages for LOSAP. Motion to accept the Chief's

report was made by Commissioner Cook, seconded by Commissioner Purnell and carried.

Fire Official's Report

Fire Official reported that inspections have begun. All registration invoices have been mailed out with the new fees. There were a total of 10 home inspections for the month of December. The solar panel signs have been given out and mounted. The Knox Box at Lazar School needs to be moved. The open burning complaint made on Conklin Farm has been handled by the state. The annual report to the State of NJ has been completed and filed. Motion to accept Fire Official's report was made by Commissioner Cook; seconded by Commissioner Purnell, and carried.
