Financial Report

Commissioners reviewed budget year to date. Motion to accept the financial report was made by Commissioner Schmidt; seconded by Commissioner Cook, and carried.

Chief's Report

Chief reported that there were 33 activities for the month of June bringing the total for the year to 192; 147 of which were fire calls. Chief reported that the fire watch during the fireworks went well. The department had a standby in the Condos that lasted eleven hours due to a possible lightening strike. The air packs have arrived. Repairs have been made to Unit 1 to fix a pinch in the wiring harness. Motion to accept the Chief's report was made by Commissioner Caggiano, seconded by Commissioner Cook and carried.

Fire Official's Report

Fire Official Serrecchia reported that there was a total of 16 home inspections for the month of June. Fire Official reported that he is interviewing for a new inspector. Inspector Kelly will be leaving due to a new job. Fire Official Serrecchia is still trying to set a date to meet with the teachers at the high school. Inspections are current. The Montville Fire Prevention Bureau may be taking back the fireworks from the state next year. Motion to accept the Fire Officials report was made by Commissioner Cook; seconded by Commissioner Schmidt, and carried.

Correspondence

- Received quotes from City Fire for the maintenance of the fire extinguishers at the three firehouses, and from R&J Controls for repairs to the generator at station one.
- Received emails regarding the progress of the repairs to the radio system.
- Received a request from the Montville Township Health Department to provide access to inspect the kitchen at station one.

Old Business

The siren at company two has been checked by Montville Electric. Repairs are not completed. There is a short in the siren itself which requires the repair be done by the company responsible for the siren. Repairs to the radios are moving along. Commissioner Lewis is working on getting quotes for the replacement of the flag pole at station two.
