RESOLUTION OF THE MONTVILLE BOARD OF FIRE COMMISSIONERS DISTRICT 1, TOWNSHIP OF MONTVILLE, COUNTY OF MORRIS, STATE OF NEW JERSEY AWARDING A CONTRACT TO ROSENBAUER FOR THE PURPOSE OF PURCHASING FIRE APPARATUS THROUGH THE NATIONAL COOPERATIVE PURCHASING AGREEMENT WITH THE HOUSTON-GALVESTON AREA COUNCIL

WHEREAS, The Montville Fire Department, District 1, has a need for a new ladder truck; and

WHEREAS, The Montville Board of Fire Commissioners, District 1, is authorized pursuant to N.J.S.A. 52:34-6.2(b)(3) to use alternate procurement methods by entering into a nationally recognized cooperative agreement; and

WHEREAS, The Montville Board of Fire Commissioners solicited quotes from three (3) vendors, with (3) of these vendors providing price quotations; and

WHEREAS, after review of these proposals, it was determined that the most cost-effective proposal that was responsive to and fully-compliant with the Boards requirements was submitted by Rosenbauer in the amount of \$1,099,070.00; and

WHEREAS, it was determined that HGAC has submitted all the required documentation for this solicitation; and

WHEREAS, consistent with P.L 2011, c. 139 the Board did conduct a cost saving determination justifying the award of this contract under a national cooperative contract; and

WHEREAS, Rosenbauer will be required to submit to the Board a copy of its New Jersey Business Registration Certificate, Statement of Corporate Ownership, and Public Contract EEO Compliance, as well as all required political contribution disclosure forms, prior to execution of contract; and

WHEREAS, The Montville Board of Fire Commissioners provided notice to the public and potential bidders of its intention to make this award by way of a Notice of Intent to Award a Contract under a National Cooperative Purchasing Agreement, a copy of which notice is on file with the District Clerk, more than ten (10) days in advance of this award; and

WHEREAS, the Rosenbauer proposal is within the funds allocated for this project and are available for this purpose; and

WHEREAS, the Board of Fire Commissioners, District 1, has certified that the funds have been appropriated and are available for this purpose

NOW THEREFORE BE IT RESOLVED by the Montville Board of Fire Commissioners, District 1, Township of Montville, County of Morris, State of New Jersey that a contract should be awarded as follows:
