Fire Official's Report

Fire Official Serrecchia reported that inspections are getting done. There was a total of 16 home inspections for the month of October. Sperro Metal has been sold to International Motors a manufacturer of cabinets for electronics. State fees for LHEAs has increased by 29%. Will ask for signed copies of the ordinances that were passed by the Township Committee. Fire Official Serrechia would like to add a section to the district website for the Fire Prevention Bureau; no objections from the commissioners. Motion to accept the Fire Officials report was made by Commissioner Purnell; seconded by Commissioner Cook, and carried.

The commissioners passed a resolution to purchase the new rescue truck from P.L. Custom Body and Equipment Co., Inc. All in favor. Commissioner Purnell made a motion to nominate Commissioner Lewis to fill the vacant position of Chairman, seconded by Commissioner Cook. All in favor.

A RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF FIRE DISTRICT NO. 1, TOWNSHIP OF MONTVILLE AUTHORIZING THE AWARD OF ONE (1) 2017 HEAVY DUTY RESCUE TRUCK TO THE SECOND LOW BIDDER, P. L. CUSTOM BODY & EQUIPMENT CO., INC.

WHEREAS, the Board of Fire Commissioners of Fire District No. 1 (hereinafter "Board"), in the Township of Montville, solicited bids for the purchase of one (1) 2017 Heavy Duty Rescue Truck to serve the Fire District; and

WHEREAS, the Board on September 14, 2017 received two (2) bids for the furnishing of said Rescue Truck to the Fire District; and

WHEREAS, the Rescue Truck Committee of the Montville Volunteer Fire Department (hereinafter "Committee") has reviewed the bids submitted by the first and second low bidders, and has found that the low bidder, First Priority Emergency Vehicles, Inc. has taken numerous exceptions to the Board's specifications, a number of which, including but not limited to, wheel base length, overall vehicle length, and vehicle height, have been determined to be critical by the Committee; and

WHEREAS, the Committee has found that the second low bidder, P. L. Custom Body & Equipment Co., Inc. has taken no exception to the Board's specifications as advertised; and

WHEREAS, the Committee has, based on its review of the bids, unanimously determined that the low bid submitted by First Priority Emergency Vehicles, Inc. should be rejected as non-responsive and the contract awarded to the second low bidder, P. L. Custom Body & Equipment Co., Inc., whose bid meets the Board's specifications in all respects; and

WHEREAS, the Board has reviewed the Committee's memorandum dated October 22, 2017, which is incorporated herein by reference, and has decided to accept the Committee's recommendation; and

WHEREAS, the Fire District Treasurer has certified that sufficient funds are available for this purpose.
