Minutes

Chief's Report

Chief reported that there were 21 activities for the month of September bringing the total for the year to 207; 149 of which were fire calls. The truck committee is reviewing the bid specs. The meeting is to be Monday October 16, after which they will take the information to the lawyer for additional review. The department will be at Montville Day on October 14, and is also having an open house on October 22 at station one. They have requested the use of the Parsippany fire prevention trailer for the open house. Parsippany has requested that we give them a COI. Commissioner Caggiano to contact our insurance

company. Motion to accept the Chief's report was made by Commissioner Cook, seconded by Commissioner Purnell and carried.

Fire Official's Report

Fire Official Serrecchia reported that inspections are getting done. There were a total of 12 home inspections for the month of September. The ordinances and fee increase have been adopted by the town at the October 10th meeting. The township committee did not have any comments or questions regarding the ordinances and the increase at the October meeting. Township committee thanked the men for attending the meeting and showing their support. State fees have also gone up. Permits have been sent out for Montville day. There is no charge as this is a town event. Commissioner Lewis has applied for RIMS access, and once he has received his access code Fire Official Serrecchia will add him as administrator. Motion to accept the Fire Officials report was made by Commissioner Purnell; seconded by Commissioner Cook, and carried.

Old Business

Discussion regarding radio reception. Radios tested with 700 band from the state. Worked outside, not inside building. Our portables are not capable of receiving 700 band frequency. Radios would need to be replaced. Radios will be discussed at the Joint Commissioners meeting at the end of the month. Paperwork needs to be changed at Optimum to appoint a commissioner as contact. Commissioner Cook will be meeting with the architect to review a conceptual plan for a building to replace station one.

New Business

Commissioners reviewed the Accident and Sickness policy. Motion was made by Commissioner Purnell, seconded by Commissioner Caggiano to increase policy limits from \$10,000 to \$100,000 on the medical coverage, and the income continuation from \$100 to \$500 per week. All in favor. Commissioner Caggiano will do a comparison of costs per person for LOSAP, uniforms and insurance. Commissioners discussed the clothing allowance. Commissioner Lewis reported that he was asked if the commissioners would be willing to assist company two redo the meeting room at station two. Commissioners would like to see a proposal and the costs.

Adjournment

Motion to adjourn the meeting was made by Commissioner Purnell and seconded by Commissioner Cook, and carried. Meeting was adjourned by Vice Chairman Lewis at 9:28 PM.
