Fire Official reported that there was a total of 20 home inspections for the month of September. Fire Inspector Baldwin received credits from the state for the NJ Transit training. The inspections on the township buildings is scheduled for next week. The ESP upgrade has not been completed yet. The Fire Official would like to upgrade the monitors and install shelves to move some computer equipment out of the work areas. Inspector Baldwin is working with the town IT to do town boundaries of the Fire Departments. Motion to accept Fire Official's report was made by Commissioner Cook; seconded by Commissioner Schmidt and carried.
