Chief's Report

There were 21 activities for the month of November bringing the year to date total to 221; 141 of which were fire calls. The Chief reported that there would be a final engineering meeting on Saturday December 10 for the new rescue truck. Santa on the fire truck is scheduled for December 17, and the company party is at station one on Sunday December 18. Unused clothing allowance was returned to the commissioners. Motion to accept the Chief's report was made by Commissioner Cook, seconded by Commissioner Caggiano and carried.

Fire Official's Report

Fire Official reported that all is going well with inspections. There were a total of 13 home inspections for the month of November. Fire Official Serrechia met with school officials regarding the use of four rooms at the high school as teacher's lounges. Fire

Official was contacted by members of the Township Committee inquiring about the use of fireworks at their reorganization meeting on January 1, 2017. Request was denied by the Fire Official. Inspections at the fire stations have been completed. Fire Prevention Bureau has been audited by the state. Motion to accept Fire Official's report was made by Commissioner Cook; seconded by Commissioner Purnell, and carried.

Commissioner Cook and Lewis are working on the specs for the roof at station two. Commissioner Cook reported that the roof at station one is leaking again. Waiting to hear on the survey regarding the radio reception in all three districts. Radio equipment was originally installed by Pinnacle. Problems in reception seem to be concentrated in District One and Two. District Three is not reporting large gaps in their coverage area.

New Business

Clerk reported that the domain name and webhosting for the public information site that the state mandates has been renewed for two years, expiring January 27, 2019. A copy of the 2017 budget has been posted to the website and two copies have been mailed to the state for approval. Motion to adjourn meeting was made by Commissioner Purnell, seconded by Commissioner Cook and carried. Meeting was adjourned by Vice Chairman Lewis at 8:20 P.M.
