Chief will check with the town regarding the ordinance for Haz Mat Spills; mutual aid or large incidences may need to go through the town. Chief submitted paperwork for a new Junior Member, Aleksander Howar. Motion to accept Chief's report was made by Commissioner Caggiano; seconded by Commissioner Lewis and carried.

Fire Official's Report

Fire Official gave his report all is going well with inspections. There were a total of eleven inspections for the month. Fire Official Serrecchia spoke to the state representative and was informed that the school inspections need to be completed before June 1. Clerk will check into putting an ad in the paper for a Fire Inspector. Motion to accept Fire Official's report was made by Commissioner Cook; seconded by Commissioner Lewis and carried.

Correspondence

Certificate of Liability insurance was received from the Girl Scouts of Northern NJ. Kearny Federal Savings bank sent notice of a change of name to Kearny Bank. Received quote from Kraft Power for annual maintenance contract for generator at Company 2.

Old Business

Commissioner Lewis said that the floors at Company 2 had been stripped and waxed. Commissioner Cook said the chair lift at Company 1 had been repaired. He also said that Alan paper won't deliver and drop off the supplies without someone present to sign for them.

New Business

Commissioners reviewed the quote from Kraft Power for the maintenance of the generator at Company 2. It was decided to use them again for the maintenance

contract. The clerk will send a letter to Diane Woltman regarding keeping the computer purchased for her use, and thanking her for her years of service to the Board.

Motion to adjourn meeting was made by Commissioner Lewis seconded by Commissioner Cook and carried. Meeting was adjourned by Chairman Berry at 8:40 P.M.
