### **Fire Official's Report**

Fire Official Joe Serrecchia reported that he has been busy with inspections on resales (list attached.) He reported that he getting a lot of calls that aren't Montville – mainly for Towaco. He is having the email address added to the Montville Messenger and the phone number taken out. The commissioners and fire official reviewed the report of audit for the Fire Prevention Bureau. Joe Serrechia stated that he is aware of the \$8,405 credit balance being held in the commissioners account on behalf of the Fire Prevention Bureau and has elected for it to remain in the commissioners account for the use of the Fire Prevention Bureau.
