WHEREAS, the Annual Budget for Montville Township FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2025 and ending December 31, 2025 has been presented before the Board of Commissioners of the Fire District at its open public meeting of November 14, 2024; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

The Fire District's proposed budget for 2025 is \$737,058 which is an increase of \$8,956 when compared to the 2024 adopted budget of \$728,102. There were significant budget increases in Capital Appropriations (\$49,000), Supplies (\$15,000), Tools and Fire Equipment (\$19,224) and the Contribution to the Length of Service Award Program (\$12,250). There were significant budget decreases in AirPacks, Hoses and Accessories (\$20,000) and Turnout Gear and Pagers (\$66,000).

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

The Fire District's 2025 proposed budget increased just over 1% from the prior year. Significant increases included supplies (\$15,000) which includes costs for disposing of foam, apparatus repairs (\$8,000) which is partially offset by a decrease in equipment repairs (\$5,400), tools and fire equipment (\$19,224), contribution to length of service awards program (\$12,250) and capital appropriations (\$49,000). We were able to offset these increases by reductions in hoses and accessories (\$20,000), insurances (\$8,200), and turnout gear and pagers (\$66,000).
