Commissioner Caggiano reported that he was attempting to ladder the CDs and that the second half of the tax levy is due this month. Received the insurance claim for the repair of 352. Motion to accept financial report was made by Commissioner Luciano, seconded by Commissioner Crownover, and carried.

Chief's Report

The Chief reported that there were 17 fire calls for the month of September, bringing the year-to-date fire calls to 188 and the total year-to-date activities to 259. The chief reported that 354 had been repaired and that the pump test on all vehicles would be done on October 13th. Inspections of the ground ladders and hose tests are complete. Three lengths of hose failed. There is an application for a new member Tyler Marszat to join Company 2. Chief is resigning effective December 31, 2024. Motion to accept Chief's report was made by Commissioner Crownover; seconded by Commissioner Luciano and carried.

Fire Official's Report

The Clerk reported in the absence of the Fire Official. For the month of September there were 10 home inspections. Seven passed first time through. Three failed – 2 passed on reinspection in September and one in October. The new reporting system from First Due was moving along. Motion to accept Fire Official's report was made by Commissioner Crownover; seconded by Commissioner Luciano and carried.

- Received past due invoices for Gen Serv; Fire and Safety.
- Received invoice from District 3 for shared services.
- Sent fee increase and ordinances to town for approval.
- Received quotes to upgrade radio equipment (receiver sites) and to replace the battery backup at Turkey Hill.
- Received a response from Anthony Bucco regarding the advertising of the JUFCRB.
- Received a request for a meeting with the Montville PD concerning the radios.

Old Business

Commissioners reviewed the Project Status report.

New Business

On a motion made and passed the Commissioners approved the application for membership of Tyler Marszat to join Company 2. All in favor. Commissioners will conduct an inspection of the fire houses on October 22, 2024. The trees at the Buffalo house have been trimmed and the brambles removed. The men will get a quote to scrape and paint at the meeting of company 1.

The motion to adjourn the meeting was made by Commission Crownover, seconded by Commissioner Luciano and carried. The meeting was adjourned by Commissioner Lewis at 9:28 P.M.
